# Local Law Firm Donates Settlement Money to Freshwater Land Trust

Donation to help protect the integrity of local rivers and streams.

The greenways work like a filter. When water runs off a parking lot or construction site it picks up silt, fertilizers, and other toxins. The trees and plants in the greenways reduce the pollutants before they can reach the water.
