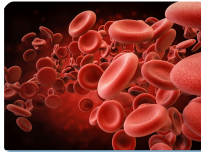


# Mass Tort Case Referral Guide

Updated: January 2026



### Bard PowerPort / AngioDynamics SmartPort

- Implanted TIVAD (not for dialysis)
- Implant after 2008 (or records available)
- Hospitalization due to: organ perforation, blood clots, embolism, infection (>30 days), or other listed complications

#### Intake Questions

1. Have you or a loved one had a port implanted to receive chemo or other medications?
2. Did you have issues with the port?



### NEC - Infant Formula

- Premature birth (<37 weeks)
- Diagnosed with Necrotizing Enterocolitis
- Fed cow's milk-based formula (Similac/Enfamil) before diagnosis
- Serious injury or death
- Born in or after 2000

#### Intake Questions

1. Was your child or a loved one's child born @ 35 weeks or before?
2. Were they diagnosed with NEC

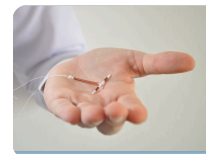


### IVC Filter (Bard or Cook)

- Filter fractured, migrated, or failed
- Removal recommended or attempted
- Injury due to filter failure

#### Intake Questions

1. Have you or a loved one had a filter implanted?
2. Did you suffer an injury from the filter or have the doctors decided they can't remove it?



### Paragard IUD Breakage

- Implanted between 2005-present
- Device broke at arm during/before removal
- Fragment retained in body
- Surgical removal required or deferred due to fertility risks

#### Intake Questions

1. Did you or a loved one have a Paragard IUD implanted?
2. Did it break upon removal?



## Paraquat Exposure

- Diagnosed with Parkinson's Disease
- Exposure to Paraquat (licensed applicator)

### Intake Questions

1. Have you or a loved one been diagnosed with Parkinson's Disease
2. Do you or they live, work, or travel by commercial farms?



## Roundup (Glyphosate) Exposure

- Exposure on or after 1974 (10+ times)
- Diagnosed with specific lymphomas or leukemias

### Intake Questions

1. Have you or a loved one been diagnosed with NHL?
2. Were you exposed to the herbicide Roundup in personal or commercial use?



## Pressure Cooker Injuries

- Malfunction caused injury requiring medical treatment
- Client still has the defective product

### Intake Questions

1. Did your pressure cooker malfunction and cause injury?



## Talcum Powder & Ovarian Cancer

- Female client
- Used Johnson's Baby Powder or Shower to Shower (not generic)
- 5+ years of use in genital area
- Diagnosis within last 2 years
- No prior cervical or endometrial cancer
- No death cases

### Intake Questions

1. Have you or a loved one been diagnosed with ovarian cancer?
2. Did you or they use J&J Baby Powder or Shower to Shower?
